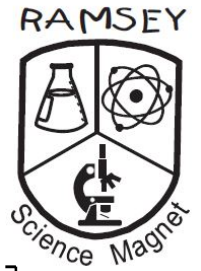

APPLICATION PROCESSING:

At the conclusion of each enrollment window, applications received are reviewed and considered by the number of available seats and any identified unique needs. If applications exceed the number of available openings, a lottery will be conducted. Within fifteen days of the close of the enrollment window, families will be notified of the status of their application. According to Board Policy 3010, *"In situations where class space is limited, the Superintendent may give priority to certain students."* In the event your child's placement on the waitlist is impacted, you will be notified by the building principal. **Parents/Guardians of accepted students will be required to accept and complete a Registration packet within one week of notification to guarantee their admission.**
