**RESOLUTION 18-19-003 CALLING FOR
SUPPLEMENTAL LEVY ELECTION**

WHEREAS, in accordance with Section 33-802(3), Idaho Code, as amended, the Board of Trustees of Coeur d'Alene School District No. 271, Kootenai County, State of Idaho (the "District"), has determined there is a need for a supplemental levy in the amount of up to twenty million dollars (\$20,000,000) each year for two years for a total amount of up to forty million dollars (\$40,000,000), for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal years beginning July 1, 2019 and ending June 30, 2021 (the "Supplemental Levy");

WHEREAS, the Board of Trustees desires to call a supplemental levy election and to submit for approval of the qualified electors of the District the proposition for approval of the Supplemental Levy.

NOW, THEREFORE, be it resolved by the Board of Trustees of the District as follows:

Section 1. That a supplemental levy election be held, and the same is hereby called to be held in the District on Tuesday, March 12, 2019, for the purpose of submitting to the qualified electors of the District the question set out in the form of the ballot appearing in Section 4 hereof.

Section 2. That on March 12, 2019, said election will be conducted by the Kootenai County Elections Department pursuant to Title 34, Idaho Code.

Section 3. That the form of notice of the supplemental levy election will be substantially as follows:

PUBLIC NOTICE IS HEREBY GIVEN according to law and requisite action by the Board of Trustees of Coeur d'Alene School District No. 271, Kootenai County, State of Idaho (the "District"), that a special supplemental levy election will be held on Tuesday, March 12, 2019, in the District for the purpose of submitting to the qualified electors of said District their vote at precinct polling sites open 8:00 a.m. through 8:00 p.m. on the following questions:

Shall the Board of Trustees of Coeur d'Alene School District No. 271, Kootenai County, State of Idaho, be authorized and empowered to levy a supplemental levy, as provided in Section 33-802(3), Idaho Code, in the amount of up to twenty million dollars (\$20,000,000) each year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the schools of the District

for the fiscal years beginning July 1, 2019, and ending June 30, 2021, all as provided in the Resolution of the District's Board of Trustees adopted January 7, 2019?

Said election will be conducted pursuant to Title 34, Idaho Code.


Section 5. That the Clerk of the Board of Trustees of the District will convey to the Kootenai County Elections Office the form of the Official Ballot and the form of the Notice of Supplemental Levy Election, appearing in Sections 3 and 4 hereof, for election preparation and publication pursuant to Idaho Code.

Section 6. That the County Commissioners of Kootenai County, Idaho, will act as the canvassing board pursuant to Idaho Code and will certify and convey the results to the District pursuant to Idaho Code.

Section 7. That if at the election a simple majority of the qualified registered electors of the District authorize the supplemental levy, the supplemental levy shall be approved and become effective in accordance with the applicable provisions of § 33-802, Idaho Code.
