Abbott BinaxNow Rapid Antigen Testing Available for Schools

Idaho Department of Health and Welfare has supplied Panhandle Health District (PHD) with Abbott BinaxNOW rapid antigen tests. PHD is distributing these tests to qualified testing sites (see below). The test provides a quick result, usually within 15 minutes. This antigen test has shown to be effective in determining infection in ***symptomatic individuals*** (those exhibiting COVID-19 symptoms). The tests are available to school students, staff and faculty. There will be no cost for the test itself. The testing site may charge an administration fee. This fee will be covered for the uninsured.

IMPORTANT: Everyone must obtain an order to be tested before proceeding to the testing site. Please call the number associated with the facility (listed below) to obtain an order.
