5. BOARD REPORT - Trustee Heather Tenbrink

Trustee Tenbrink thanked members of the committee that helped pass the levy. District administration and the Board of Trustees will look for additional money to help fund maintenance issues.

6. SUPERINTENDENT'S REPORT – Dr. Shon Hocker, Superintendent

May 16 Levy Election Update
 Dr. Hocker said that District Administration will look at ways to tighten and 'right-size' the District's budget, in which some classified staff may be reduced and some

certified staff may be moved around. The State of Idaho funded a salary increase for most certified staff, but not all.

b. Renaming of Venture High School to Venture Academy Dr. Hocker reported that Venture High School is in the process of being renamed to Venture Academy and will include Coeur d'Alene Virtual Academy (CDVA) students in grades 6-12 beginning the 2023-24 school year. Offering CDVA opportunities to elementary students is still in discussion.

7. LONG RANGE FACILITIES PLAN – Chair Lindsey Swingrover & Jeff Voeller, Director of Operations

a. Committee Summary

Chair Swingrover reviewed the Facilities Plan voted on and approved by the committee and asked what else should be included with the Board report in June. Jeff Voeller said the District has enough funds to minimally fund maintenance for about 1.5 years, but is still short about \$6 million each year. The District has about \$5 million for maintenance now, but some of that money has already been earmarked for projects. Nancy Hart asked about the School Plant Facilities Levy (SPFL) and when the District would try to run that again. Dr. Hocker spoke about the timing of running levies. Jason Hover asked if the committee should recommend to the Board when to run an SPFL. The group discussed how to be more transparent in marketing a levy and what can be learned from the supplemental levy passage that can help an SPFL to pass. A suggestion was made to possibly survey the public. There may be a need to clarify the different maintenance requirements with the public.

8. FACILITIES AND PLANNING – Jeff Voeller, Director of Operations

a. Construction Update

Mr. Voeller reported that part of Coeur d'Alene High School will get an HVAC replacement this summer for about \$5 million. Entrances will be revamped for security measures at 4 elementary schools this summer; two more schools will be renovated next summer. A new cross walk beacon will be placed outside of Woodland Middle School, funded through Sunrise Rotary. Constance Bond asked that clearer signage be placed at Woodland. Chris Bosley reported that additional crosswalks will go out to bid and eventually be constructed on Hanley Avenue.
